## Notice of Race

### Jack and Jill Race

Aug 12, 2023

#### 1. Rules

- 1.1 The Race will be governed by the rules as defined in the *Racing Rules of Sailing 2021-2024*.
- 1.2 White Sail only.
- 1.3 One day race event

#### 2. Sailing Instructions

- 2.1 The Sailing Instructions will be posted on the SBYC website, available from your Fleet Captain and at the Skippers' meeting.

#### 3. Communication

- 3.1 All boats shall carry a VHF radio capable of communicating on Channel 72.
- 3.2 On the water, the race committee will make courtesy broadcasts to competitors on the VHF radio. The Channel will be confirmed in the SIs.
- 3.3 Except in an emergency, a boat that is racing shall not make voice or data transmissions and shall not receive voice or data communications that are not available to all boats.
- 3.4 The Race Officer may communicate with the race fleet on channel 72.

#### 4. Eligibility and Entry

- 4.1 The Regatta is open to all monohull boats from the *Edmonton Yacht Club or the Sunshine Bay Yacht Club (exceptions by special request)* and have submitted a completed Registration Form.
- 4.2 From the warning horn until the boat crosses the finish line only the female member of the racing team is allowed to helm the boat. White sails only.
- 4.3 Rating handicaps will be assessed and assigned by the PHRF Committees. Each participating boat needs to have completed a Registration and Inventory Form to be scored with the Wabamun PHRF ratings.

#### 5. Fees

- 5.1 Visit the race registration form for fee information. Race fees are payable by cash or cheque to the Sunshine Bay Yacht Club or Interac [fees@sunshinebay.org](mailto:fees@sunshinebay.org) (preferred) with comment Jack and Jill Race Fee.
- 5.2 Entry fee must be paid prior to the race.
- 5.3 Boats will not be recorded or scored that have not submitted an entry form or paid their fees.
- 5.4 Credit or debit payments are not available.

#### 6. Awards

- 6.1 Awards will be made to the 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> place overall finishing boats.
- 6.2 All boats will be placed for finish based on their final score as per the PHRF Wabamun Lake handicap rating program.

#### 7. Schedule

- 7.1 Registrations will be taken up to 0920h on race day. See SBYC website for e-Registration Forms.

- 7.2 Skippers meeting will be at 0930h August 12<sup>th</sup> at the SBYC Clubhouse deck.
- 7.3 Sailing Instructions will be available on the SBYC website and at the Skipper's meeting.
- 7.4 Start of the 1<sup>st</sup> race will be 1100h.
- 7.5 Number of races: Target is 3-4 races. No race will be started after 3pm Saturday.
- 7.6 One race will constitute a series.

**8. Course**

- 8.1 The course length will be less than 2.5 nautical miles. The actual course length, course diagram and location of marks will be available at the Skipper's meeting.

**9. Scoring**

- 9.1 One race constitutes the series.
- 9.2 Final finish times will be determined after applying Wabamun PHRF correction factors.

**10. Risk Assessment**

- 10.1 RRS 3 states: DECISION TO RACE is the responsibility for a boat's decision to participate in a race or to continue racing is hers alone. See RRS 3, Decision to Race.
- 10.2 The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during or after the regatta.

**11. Insurance**

- 11.1 Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$1,000,000.00 per incident or the equivalent.

**12. Rights to Use Name and Likeness**

- 12.1 In participating in this event, a competitor automatically grants the *Organizing Authority* and the sponsors the right in perpetuity, to make, use or show, from time to time and at their discretion, any motion pictures, still pictures and live taped or film television and other reproductions of him/her during the period of the competition for the said event in which the competitor participates in and all material related to the said event without compensation.
