Failure to supply the said insurance document proof or failure to ensure that adequate insurance coverage is in place at all times is a material breach of this Agreement and entitles SBYC to terminate this Agreement.

AGREEMENT TERMS

TERM: The original Term shall be from March 1, 2026 to February 28, 2027 (the "Term")

RULES & REGULATIONS:

As a member of the Sunshine Bay Yacht Club (SBYC), I shall abide by the SBYC Bylaws, Code of Conduct, Rules and Regulations, and Club Policies, commonly referred to as "Rules & Regulations", as amended or replaced from time to time. The current Rules & Regulations and Code of Conduct are available on the Members Page of the Sunshine Bay Yacht Club web site www.sunshinebay.org and supersedes all other versions.

Termination by SBYC for Cause

Without further notice, SBYC shall be entitled to terminate this Agreement and re-assign the Slip with no further notice to the Member in the following circumstances:

- a. the Member has not paid their Dues and Fees, or any other assessments or debts as required in the Club's Bylaws and subject to "Regulations and Club Policies";
- b. the Member failing to maintain insurance as required hereunder and providing proof of insurance; and
- c. the Member, or the Member's family, guests, or invitees, violating any other term of this Agreement.

Termination by SBYC Not for Cause

Notwithstanding anything else herein to the contrary, SBYC shall be entitled to terminate this Agreement at any time without cause by providing the Member 30 days' notice and a refund of any Moorage paid which is applicable to the period of time after this Agreement is terminated.

As a member of the Sunshine Bay Yacht Club (SBYC), I shall support club activities and events by volunteering each season. In addition, I give permission for SBYC to send electronic communications to the email addresses provided above and for the club to use images of myself and members of my family in club publications, on their website and social media pages. As a member, I also agree to SBYC publishing my emergency contact number in the clubhouse and on the member only page of the website. SBYC will not sell your contact information to any party.
